

**Rules of the contest for the best scientific poster**  
**1st International Scientific Conference**  
**“New Forms of Employment. Current Problems and Future Challenges”**  
**Rzeszow, Poland 26-27 November 2018**

**§1 Definitions**

1. Organizer –the Institute for Labour Law and Social Security at the Faculty of Law and Administration of the University of Rzeszow, Institute for Labour Law at Institute of Legal Sciences of the Polish Academy of Sciences and the Labour Law and Social Security Institute.
2. Session of Scientific Posters – the public presentation of scientific posters on 27 November 2018 at the University of Rzeszow in the course of the 1st International Scientific Conference “New Forms of Employment. Current problems and Future Challenges”.
3. Contest – Contest for the best scientific poster in the course of the 1st International Scientific Conference “New Forms of Employment. Current problems and Future Challenges”.
4. Participant – author/authors of scientific poster in the course of the 1st International Scientific Conference “New Forms of Employment. Current problems and Future Challenges”, wishing to participate in the contest for the best scientific poster by submitting poster.
5. Conference – 1st International Scientific Conference “New Forms of Employment. Current problems and Future Challenges”, which is scheduled for November 26-27, 2018 at the University of Rzeszow.

**§2 General terms**

1. The submission an registration form for the Conference is equivalent with the acceptance of these Rules.
2. Organizer reserves the right to amend the Rules. In this case Organizer is obliged to notify participants thereof.
3. Posters shall be the original work under the provisions of the Act on Copyrights and Related Acts of 1994.
4. The submission an registration form for the Conference is equivalent with the consent for the publication of electronic version of poster on Conference Facebook account and at the Conference website and on the Organizers Facebook account.
5. The correct course of contest is supervised by the Organising Committee of the Conference.

### **§3 Participants/Application**

1. Participants in the contest include all authors of scientific posters who expressed their interest in taking part in a contest by submitting, within a specified time limit, a complete application form (thus registering on the Conference) and poster incorporating all formal requirements specified by Organizer. The maximum number of authors is 3.
2. The application shall be made by submitting an electronic version of poster to the e-mail: [labourlaw@ur.edu.pl](mailto:labourlaw@ur.edu.pl) with information on authors (including their affiliation) and together with the scanned and signed Annex no 1 to this Rules at the date indicated in § 4.
3. The electronic version of poster shall be saved in the format JPEG (sRGB). The file shall not exceed 5MB. Organizer reserves the right to modify the file (size/resolution/format) in case of difficulties related to its editing or publication on the website.
4. Organizer shall not take responsibility for the quality of the published photo, however one should remember that the quality of the photo affect its visual reception and assessment.

### **§4 Schedule**

**15.10.2018** not later than till 11:59 p.m.– the final closing date for submission of electronic version of posters to the e-mail: [labourlaw@ur.edu.pl](mailto:labourlaw@ur.edu.pl) with information on authors (including their affiliation).

**20.10.2018** – publication of electronic version of posters on Conference Facebook account and at the Conference website and on the Organizer Facebook account.

**27.11.2018** – the announcement of the poll results during the poster session on a date set out in the Conference schedule. Organizer reserves the right to modify the time of the results being announced, if the Conference schedule has change. In this case Organizer is obliged to notify participants thereof.

### **§5 Contest procedure**

1. Submission the electronic version of the poster by participants.
2. Publication of the electronic version of posters on Conference Facebook account and at the Conference website and on the Organizer Facebook account on 20.10.2018.
3. Voting by Internet users. The vote shall be adopted by “like” photo showing an electronic version of the poster.
4. Counting the votes – the number of votes will be presented on Conference Facebook account on 27.11.2018 at 12.00 a.m.
5. Announcement of the results during poster session and the awarding ceremony.
6. For the first place the prize is the fountain pen. For the second and third place the prize pendrive.
